Per the laws in Pennsylvania, if you have been convicted of a DUI on a first offense, the fine will be in the range of \$300. However, the fines and potential penalties increase significantly for subsequent offenses: A second DUI conviction can lead to a fine of up to \$2500. Anyone convicted of a third offense could face a fine of up to \$5000. Avoiding paying the extremely high fines is reason enough to seek out the help of a qualified DUI lawyer in Montgomery County, PA. Frequently, a successful lawyer can petition the court for a lower fine and do so successfully based upon the particulars of the case.

While the fines are significant, there are other penalties that can be levied when you have been convicted of a DUI. A Pennsylvania DUI lawyer might very well be able to protect you against having your license suspended for a full 12 months in the aftermath of being convicted on a second or third DUI offense. When your license is suspended, you will find yourself in a very difficult situation. Not being able to drive your car means you may not be able to travel to work easily - if at all. Your situation can further be compounded by the fact your ability to take care of many normal aspects of daily life will be undermined when you cannot drive. Of course, the most serious of all implications facing someone charged with driving under the influence would be the jail time associated with a conviction. A second offense could lead to five days to six months in jail. For the third offense, you will discover that the jail time is in the range of ten days to upwards of two years.
