The 9/11 Health and Compensation Act got its name from a brave police officer, James Zadroga. He was an officer of New York police department who spent more than 450 hours in saving the lives of many victims at the rescue site. While spending more than 450 hours at the ground zero cleanup process, he came in close contact with harmful toxins called asbestos, due to which he was detected with high amount of respiratory disorder. While carrying out the rescue operation James Zadroga along with other volunteers, fire fighter, clean up workers, construction workers inhaled a huge amount of Asbestos and died due to respiratory problem.

The volunteers were also detected with serious health condition such as Upper or Lower Airway Disease, Acid Reflux Disease, Obstructive Airway Diseases such as chronic bronchitis, emphysema or chronic obstructive pulmonary disease (COPD); occupational asthma (WTC Cough), Sarcoidosis, Asbestosis and Mesothelioma Cancer.
