Definitions of domestic violence do vary between states; however, these types of charges are normally the result of domestic battery, some form of sexual assault, kidnapping or endangerment of some form, and also false imprisonment. If you are convicted of this crime, you are left with a criminal record that is permanent. This type of record has dire consequences; for instance, if you hold any type of professional license, it may be revoked. You also lose the right to own a firearm.

Thus it is obvious that if you are accused in the state of Colorado, you will require a Denver Domestic Violence Attorney. Lawyers that are skilled in this area of the law can help you prepare a solid defense, possibly avoiding a conviction. If this is the first time that you have ever been accused of such a crime, the attorney can fight for your rights to a pre-trial diversionary program. By participating in this program, you may be able to have the charges against you reduced or even dropped altogether.

If there is a restraining order in place, and you have violated it, the penalties for such can be extremely harsh. For this reason, you must hire adequate and competent representation. This is the only way that you will be able to navigate the complex legal system and ensure that your rights are protected.

Many times, you can be falsely accused, as the spurned person in the relationship wants payback for an eroded relationship. Regardless of whether you know that there is no basis to the accusation, you still must defend yourself with a Denver domestic violence attorney.
