Many people prefer to settle in Canada because of the nation's sustained growth and the availability of jobs. The Canadian government both federal and provincial are helping people to immigrate by updating programs regularly so that immigration for Canada becomes simpler. In order to immigrate and be a citizen of that nation, you have to put in an application for a Canadian Immigration Visa which is also referred to as the Permanent Resident.

Immigration through Family Class Sponsorship

Family immigration to Canada requires you to have a relative who can sponsor you. This relative should be a citizen. There are a few conditions by which you can qualify for a family class sponsorship.

• The relative should either be your spouse, conjugal partner or even a common law partner.

• The relative can be a dependent child, brother or sister, niece or nephew. The relative can also be an orphaned grandchild who is below 18 years, unmarried and should not be in a common-law relationship. The relative can also be an intended adopted kid below 18 years.

• Further, for family immigration, the sponsor should be a citizen of Canada or a Canadian Permanent Resident.

Immigration Appeal

The division for immigration appeal looks after all appeals. There are three types- the spousal, residency or criminality appeals.

The common ones are the spousal appeals. Firstly, the sponsor is interviewed and the refusal letters are perused. If they are happy with all your reasons, the department may most likely represent you. If there has been an error in the process, the appeal should be filed with the immigration appeal division.

In the case of a criminality appeal, if the permanent resident has a criminality record against him, then an immigration appeal is required. The Canada Border Service Agency will interview you regarding the conviction. If the CBSA is not happy with you, they can even deport you.

The final immigration appeal is the residency appeal, where the permanent resident submits an application for renewal. If it is shown that you have not complied with the residency pre-requisites, the PR card will not be renewed and the application is forwarded for further investigation.

Immigration Lawyer

If you require an immigration lawyer, there are several of them who are competent enough to take your case. A good lawyer will help you so that your immigration to Canada is made easy. Most lawyers give free service for the initial assessment. This requires filling in an online assessment questionnaire. There are several law firms that specialize in immigration cases where you can avail of a competent licensed immigration lawyer to represent you in all matters of immigration.
