Australian spouse visa is granted to those applicants who are married to permanent Australian citizens. This visa only offers pros and there are hardly any cons. However, before we discuss the pros or advantages of this visa let's take a look at the basic requirements for this visa.

Australian spouse visa can be applied from either inside or outside Australia. Before you apply for this visa you must remember that in its initial stage the visa is granted temporarily. After two years the applicant's relationship with their respective spouse is reassessed and if the relationship is considered genuine and strong then permanent visa is granted to the applicant. Also the applicant must be sponsored by their Australian partner.

The basic requirement of this Australian partner visa is the applicant must be married or in a DeFacto relationship either with an Australian citizen or an Australian permanent citizen. The applicant must be sponsored by their respective partners and must be minimum 18 years of age. If this Australian relationship visa is applied by a married applicant the marriage must be legal according to the laws of Australia. In case of DeFacto relationship the applicant must have been in a relationship for a minimum period of 12 months and the applicant must demonstrate genuine commitment to their partner. DeFacto partner definition extends to opposite and same-sex partner.

After the relationship of the applicants with their partners is found genuine and continual a permanent Australian spouse visa is granted. Holder of this visa becomes a permanent citizen of Australia and is entitled to live, work and study on permanent basis in the country. This is one of the biggest advantages of Australian spouse visa. Some of the additional benefits include access to government-subsided healthcare, several security benefits and eligibility to apply for Australian citizenship. Therefore, it is ideal for those applicants who wish to stay with their partners in Australia and want to be citizens of Australia.

There are hardly any cons related to this Australian partner visa. But the applicant must keep certain things in mind. One of the first and foremost things is the applicant must submit the required documents properly. Improper submission of documents might lead to rejection in application thereby delaying the visa process.

Thus, in order to avoid any kind of confusion it is very important that you take professional help to ensure that your visa is granted on time and that too without any difficulty. Here you must conduct some background check on the service selected so that you can be sure of the service. Moreover, the reason for selecting a professional visa service is their experience in visa application.
